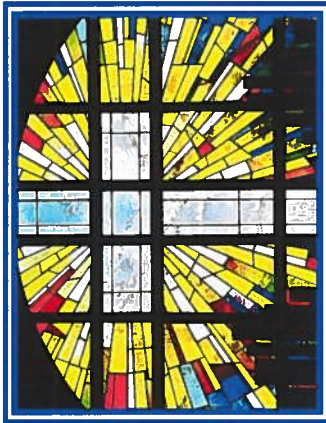

other professional advisors. The funds
may be used for capital improvements,
outreach programs and other ministries;
only in an emergency will they be used
for normal maintenance and operating
expenses.
